These terms and conditions as contained herein shall form as an agreement between the Vendor and Buyer. "Vendor" includes and refers to the acceptor of this PO.</div><div>2. Vendor shall comply with all applicable central, state, and local laws, Government orders, and regulations in fulfilling this PO.</div><div>3. Kindly note that the products are subject to verification at our end. We shall get back to you in case of any issues regarding quality, defects or deficiencies.</div><div>4. Vendor shall supply the products in compliance with any specifications, and schedule set forth in the PO. Time is of the essence.</div><div>5. All products must comply with quality standards as per applicable laws and shall be supplied at least 80% of its shelf life remaining at the time of delivery.</div><div>6. Vendor shall bear the risk of loss of products (including damage, shortages etc) until its receipt and acceptance by us.</div><div>7. This PO shall be valid till the delivery date mentioned in the PO.
