For the stocks once received (GRN completed), the payment will be remitted as per PO rates. Please verify that Challan no. & physical delivered cartons are correctly mention on IRN.

Should any disputes arise pertaining to this matter, please submit a request within 10 days of delivery; after this period, no such requests will be subject to investigation.
