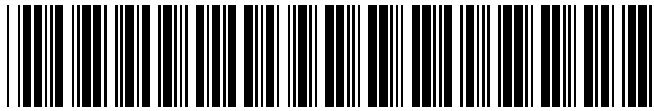

Please verify that Challan no. & physical delivered cartons are correctly mention on IRN.
