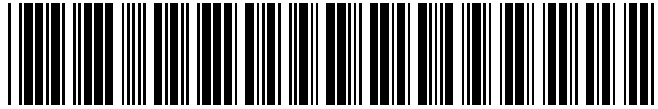

In case of any variation between PO and invoicing rates, vendors should get the purchase order revised as per the agreed commercial terms.
